CHIEF GENERAL MANAGER, HIGH EXPLOSIVES FACTORY, KHADKI, PUNE, invites applications for engagement as Apprentices in accordance with the provisions contained in the Apprentices Act, 1961 (amended in 1973, 2014 & 2019) for providing practical training to fresh Engineering Graduates & Diploma (Technician) in Chemical Engineering, Mechanical Engineering, Electrical Engineering & General Stream Graduates for a period of one year during 2025-26 as per the details given below :-

2) **ESSENTIAL EDUCATIONAL QUALIFICATION :-**

Engg. Graduate Apprentice : Degree in Engineering/Technology or from a recognized University
Diploma Technician Apprentice : Diploma in Engineering/Technology from State Board of Technical Education .
General Stream Graduate Apprentice : Degree in General Streams from a recognized University (* as mentioned below)

* General Stream Graduates : Degree in Bachelor of Arts, Bachelor of Science, Bachelor of Commerce, Bachelor of Computer Applications, Bachelor of Business Administration, Bachelor of Hotel Management, Bachelor of Fashion Designing, Bachelor of Management Science, Bachelor of Fine Arts, Bachelor of Event management, Bachelor of Journalism and Mass Communication, Bachelor of Social Work, Bachelor of Business Studies, Bachelor of Travel and Tourism Management, Bachelor of Design and Bachelor of Performing Arts.

Only Freshly Pass Out students of the trade / discipline notified above notified trades / disciplines are eligible for apprenticeship training for up to 4 years after passing their degree/diploma as on last date for receipt of applications. Engineering Graduate, General Stream Graduates and Diploma holders who had training or job experience for a period of one year or more after attaining/acquiring the essential qualification shall **NOT** be eligible to be engaged as an apprentice under the Act.

If there is a gap of more than one year between the date of declaration of result and date of commencement of training, candidates are required to submit, an affidavit on stamp paper duly signed by Magistrate/Notary. The subject matter of the affidavit Shall remain same as the declaration in the format enclosed as **Annexure – 'B'**

3) **SELECTION PROCEDURE**

Selection will be made on the basis of merit list prepared on the basis of marks obtained in the final year examination ie, CGPA percentage for Engineering Graduates/Technician.

Candidates meeting the eligibility criteria should forward their completely filled application forms in the prescribed format by post along with declaration that they will produce / submit all the desired documents at the time of Document Verification. In case of failure to produce/submit any of the desired & essential documents, their candidature will be rejected.

Deferment / postponement of date of Document Verification (when notified) will not be permitted/considered.

Candidates found eligible in Document Verification will be called for Medical Examination before joining after receipt of satisfactory online Police Clearance Certificates (PVRs)/Verification of Character antecedents. Candidates found FIT in Medical Examination will be issued joining letter for Apprenticeship Training.

4) **GENERAL INFORMATION**

Application form (as per Annexure-A) should be forwarded in a sealed envelope with title as "APPLICATION FOR ENGAGEMENT AS GRADUATE/DIPLOMA APPRENTICE". Incomplete applications/applications received after the last date will not be considered.

6) **RESERVATION**

It is necessary to submit a copy of the certificate from the competent issuing authority as per the provisions contained in the Apprentice Rule 2015 for obtaining reservation. OBC candidates are required to submit a valid Non-Creamy-Layer-Certificate (NCLC) by the last date of receipt of applications. Candidates not having a valid certificate in respect of Reservation will be considered as unreserved candidates.

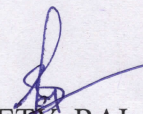
7) **LAST DATE FOR SUBMISSION OF APPLICATIONS**
